## BOARD OF COUNTY COMMISSIONERS DOUGLAS COUNTY, NEBRASKA

**WHEREAS**, at its July 10, 2018 meeting, this Board approved a resolution directing Douglas County to offer Marcy Mason, LLC nine hundred thousand dollars (\$900,000) in exchange for fee simple title to the property located at 420 South 18<sup>th</sup> Street in Omaha, Nebraska and, in the event the offer was rejected and negotiations failed, directing the County to file an eminent domain petition to condemn the property; and,

WHEREAS, the offer was rejected and negotiations failed, and thus the County filed the eminent domain petition to commence the condemnation proceeding; and,

**WHEREAS**, this Board now desires to rescind that July 10, 2018, resolution and to dismiss the condemnation proceeding.
